- In **California**, an abortion clinic owner was sentenced to nearly 7 years in prison. Two of her employees – including her own sister – were also arrested and convicted for helping her commit illegal abortions.
- In **Florida**, abortion worker Belkis Gonzalez was arrested for illegal abortions in Miramar then arrested again for trying to cover up for a botched abortion in Hialeah. Her associate, Siomsara Senesis, was also arrested.

- In **Nebraska**, some former abortion workers came forward and told of how they were instructed to break the law. Their former boss is now under criminal investigation AND other workers have been implicated.
