Dear Colleague:

As you may know, Massachusetts law requires parental or judicial consent for anyone under eighteen years old who is seeking an abortion. The Planned Parenthood League of Massachusetts (PPLM) provides free, confidential counseling and assistance to young women facing unintended pregnancy through our Counseling and Referral program.

Specifically, trained counselors discuss all pregnancy options with teens and explore the possibility of involving their parents in their decision. If they decide to have an abortion but are unable or do not choose to obtain their parents' consent, Planned Parenthood's counselors help teens obtain court consent.

The enclosed, recently updated brochure describes the parental consent law and how it is implemented. We would appreciate your sharing this information with your colleagues and staff. I have also included a brochure detailing the services offered by our Brookline and Worcester clinics. The Planned Parenthood Clinic of Greater Boston opened in February 1987; the Planned Parenthood Clinic of Central Massachusetts has operated since December 1982. Both clinics offer a full range of contraceptive, gynecological, and abortion services.

To further inform you about the law, Planned Parenthood will hold a brief educational seminar on the parental/judicial consent law on Thursday, March 7, from 7:00 to 9:00 p.m. at the administrative offices of the Planned Parenthood League of Massachusetts, 99 Bishop Allen Drive, Cambridge, MA. Featured speakers will be attorneys from PPLM's Lawyer Referral Panel. Please call Carol Lynch at (617) 731-2933 if you are interested in attending.
