

**Transcript for 911 Call Placed September 14, 2013, from  
Cleveland Surgi-Center, 4269 Pearl Road, Cleveland, Ohio**

**Dispatcher:** Cleveland EMS. What's your emergency?

**Abortion Clinic Caller #1:** We have a patient that seizing right now. She's on Depakote. We're at 4269 Pearl Road.

**Dispatcher:** Okay. Is this the Dialysis Center?

**Abortion Clinic Caller #1:** No, it's the Cleveland Surgi-Center abortion clinic.

**Dispatcher:** Oh, it's an abortion clinic?

**Abortion Clinic Caller #1:** Yes, sir.

**Dispatcher:** Okay. Is there a – a floor or a room number?

**Abortion Clinic Caller #1:** Yes. Fourth floor, room 11.

**Dispatcher:** Room 411.

**Abortion Clinic Caller #1:** --And you'll have to come to the back door.

**Dispatcher:** Alright, go to the back door?

**Abortion Clinic Caller #1:** Um-hum. You know, go down Devonshire and then there's a little one-way street by the senior wellness center.

**Dispatcher:** Okay. I don't know if they've been there before or not. Um, I'll just give them the directions.

**Abortion Clinic Caller #1:** Okay.

**Dispatcher:** Could I have the phone number you're calling from, please?

**Abortion Clinic Caller #1:** Sure. 216-272-0666

**Dispatcher:** Okay. Are you with the patient?

**Abortion Clinic Caller #1:** No, I'm not. I can give you to the nurse if you want to talk to her?

**Dispatcher:** Um, sure.

**Abortion Clinic Caller #1:** Okay, hold on, please.

**Dispatcher:** Alright.

**Abortion Clinic Caller #1:** *[To someone in the room]* They want to talk to a nurse. *[Background conversation]* They want a nurse. *[Unintelligible.]* Here you go, ma'am.

**Abortion Clinic Caller #2:** Hello?

**Dispatcher:** Yes, hi.

**Abortion Clinic Caller #2:** Hi. I have a patient here that we just – uh – she’s had an abortion. She has a seizure disorder. Uh, when she was waking up, she seems to be in tonic-clonic\*, her lips are blue, she’s having difficulty breathing --

**Dispatcher:** Okay.

**Abortion Clinic Caller #2:** --she’s non-responsive.

**Dispatcher:** So she’s already done having the procedure?

**Abortion Clinic Caller #2:** I think she’s been having a seizure for a good 5 minutes here.

**Dispatcher:** Okay. How old is she?

**Abortion Clinic Caller #2:** Uh, she’s in her 30’s with, uh --

*[Unintelligible background conversations]*

**Dispatcher:** Okay. Is she awake right now?

**Abortion Clinic Caller #2:** No, she’s not responsive. She seems to be going back into seizures again. She’s 24.

**Dispatcher:** She’s 24?

**Abortion Clinic Caller #2:** Yeah.

**Dispatcher:** But she is breathing, right?

**Abortion Clinic Caller #2:** Uh...sporadically.

**Dispatcher:** Okay. I’m going to send them over there right now.

**Abortion Clinic Caller #2:** Okay.

**Dispatcher:** Okay?

**Abortion Clinic Caller #2:** Alright.

**Dispatcher:** Alright, thank you.

**Abortion Clinic Caller #2:** Alright.

**Dispatcher:** Bye.

**Abortion Clinic Caller #2:** Bye-bye.

\*A patient that is “tonic-clonic” is suffering seizures with muscle contractions.
