On Tuesday 2-23-16, at about 1521 hours, I was dispatched to 2500 H Street, Family Planning, regarding protesters standing in the road way. Upon my arrival I contacted a subject identified as THEODORE AURAND. Officer Gill #1300 and Senior Officer #997 assisted me with the investigation (see their supplemental reports for further details).

AURAND stated on 2-23-16, at about 1445 hours, he observed protesters blocking an ambulance from leaving the business. He stated protesters were yelling and filming a patient entering the ambulance. Staff members attempted to block the protesters from filming with big white sheets. He picked up a sheet and assisted them. He stated on subject, identified as TIMOTHY TIMOTHY PALMQUIST, was standing on top of a metal structure that was on the side walk, and was filming over the top of the sheet. He stated he approached him, and held up the sheet to prevent him from filming. He stated TIMOTHY PALMQUIST began pushing him away. He stated he continued to arque with the protesters after the ambulance had departed from the facility. He stated he slipped and broke the crosses that been placed in the grass on the west side of the building. He stated he did not wish to pursue charges against TIMOTHY PALMQUIST; however, would if TIMOTHY PALMQUIST pursued charges against him. I asked him if he had touched TIMOTHY PALMQUIST, and he said, "No." I asked him if he broke the crosses on purpose, and he said, "No, I slipped".

I contacted TIMOTHY PALMQUIST who initially refused to provide officers with his information. TIMOTHY PALMQUIST stated on 2-23-16, at about 1440 hour he was standing on the west side of the facility protesting and filming with his camera. He stated he was filming, and was approached by AURAND who was carrying a white sheet. He stated pushed him with the sheet in his chest approximately eight times. He stated then broke the crosses that were implanted in the grass along the west side walk of the business by kicking them. He advised me he had video of the incident, and wanted to pursue charges against AURAND. I asked TIMOTHY PALMQUIST if he pushed AURAND, and he said, "No, I did not touch him."

I watched the video footage. I observed AURAND approach TIMOTHY PALMEQUIST with the white sheet; however, the video did not show the physical contact between them. I also observed AURAND kick and break to of the crosses. Officer Gill seized the video, and later downloaded them into DIMS.

I contacted TERRI PALMQUIST who stated on 2-23-16, at about 1445 hours she was protesting on the west side of the business with TIMOTHY PALMQUIST. She stated she observed AURAND approach TIMOTHY PALMQUIST with a white sheet, and push him. She stated AURAND then approached her and began yelling in her face. She stated as they were arguing in each other's faces AURAND's stomach touched her. She stated AURAND then broke Two of the crosses she had place in the grass on the west side walk of the business. She stated she wished to pursue charges against AURAND for touching her with his stomach, and breaking her crosses. She valued the damage to the crosses at \$10.

I observed eight wooden crosses on the west side walk of the facility. Two of the crosses been broken at the lower portion of the cross. I took photographs of the crosses, and later downloaded them into DIMS.

I provided TERRI PALMQUIST with a BPD Victim's Assistance Guide with the case number.

I accepted AURAND, and TIMOTHY PALMQUIST's private person's arrest. I also accepted TERRI PALMQUIST's private person's arrest against AURAND for the vandalism to the crosses.

I cited (BP310751) and released AURAND on scene for violation of P.C. 243(d) - battery, and P.C. 594(a) (2).

I cited (BP310752) and released TIMOTHY PALMQUIST for violation of P.C. 243(d) - battery.
