ALONG WITH SERVING THE PUBLIC, PROFESSIONAL COMMUNITY AND DONOR HOSPITALS, LIFEBANC PROVIDES LIFE- SAVING ORGANS TO TWO TRANSPLANT CENTERS: THE CLEVELAND CLINIC AND UNIVERSITY HOSPITAL CASE MEDICAL CENTER. RECOVERED TISSUE IS TRANSPLANTED COUNTLESS TIMES IN HOSPITALS THROUGHOUT THE REGION. IN 2013, LIFEBANC HELPED TO HEAL AND SAVE MORE THAN 500 LIVES. 
