20 STEWART L. BELL, District Attorney within and for the County of Clark, State of
21 Nevada, in the name and by the authority of the State of Nevada, informs the Court:

22 That ADAM LEVY, the Defendant(s) above named, having committed the crimes of
23 SEXUAL ASSAULT WITH A MINOR UNDER SIXTEEN YEARS OF AGE (Felony -
24 NRS 200.364, 200.366) and LEWDNESS WITH A CHILD UNDER THE AGE OF 14
25 (Felony - NRS 201.230), during or between 1995 and 1997, within the County of Clark, State
26 of Nevada, contrary to the form, force and effect of statutes in such cases made and provided,
27 and against the peace and dignity of the State of Nevada,

28 COUNT I - SEXUAL ASSAULT WITH A MINOR UNDER SIXTEEN YEARS OF AGE
did, during or between 1995, and 1997, then and there wilfully, unlawfully, and
feloniously sexually assault and subject [REDACTED], a female child under sixteen years
of age, to sexual penetration, to-wit: cunnilingus, by licking and/or inserting his tongue into the

1 vagina of the said [REDACTED] against her will, or under conditions in which Defendant
2 knew, or should have known, that the said [REDACTED] was mentally or physically
3 incapable of resisting or understanding the nature of Defendant's conduct.

4 COUNT II - LEWDNESS WITH A CHILD UNDER THE AGE OF FOURTEEN

5 did, during or between 1995, and 1997, then and there wilfully, lewdly, unlawfully, and
6 feloniously commit a lewd or lascivious act with the body of [REDACTED] a child under
7 the age of fourteen years, by touching and/or fondling the vagina of the said [REDACTED]
8 [REDACTED], with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires
9 of said Defendant, or said child.

10 COUNT III - LEWDNESS WITH A CHILD UNDER THE AGE OF FOURTEEN

11 did, during or between 1995, and 1997, then and there wilfully, lewdly, unlawfully, and
12 feloniously commit a lewd or lascivious act with the body of [REDACTED], a child under
13 the age of fourteen years, by rubbing his penis on the vagina of the said [REDACTED],
14 with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of said
15 Defendant, or said child.

16 COUNT IV - LEWDNESS WITH A CHILD UNDER THE AGE OF FOURTEEN

17 did, on or about February 19, 1997, then and there wilfully, lewdly, unlawfully, and
18 feloniously commit a lewd or lascivious act with the body of [REDACTED], a child under
19 the age of fourteen years, by touching and/or fondling the breast of the said [REDACTED]
20 [REDACTED], with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires
21 of said Defendant, or said child.

22 COUNT V - LEWDNESS WITH A CHILD UNDER THE AGE OF FOURTEEN

23 did, during or between 1995, and 1997, then and there wilfully, lewdly, unlawfully, and
24 feloniously commit a lewd or lascivious act with the body of [REDACTED], a child under
25 the age of fourteen years, by touching and/or fondling the buttocks of the said [REDACTED]
26 [REDACTED], with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires
27 of said Defendant, or said child.

1 COUNT VI - LEWDNESS WITH A CHILD UNDER THE AGE OF FOURTEEN

2 did, during or between 1995, AND 1997, then and there wilfully, lewdly, unlawfully, and
3 feloniously commit a lewd or lascivious act with the body of [REDACTED], a child under
4 the age of fourteen years, by rubbing his penis on the stomach of the said [REDACTED],
5 with the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of said
6 Defendant, or said child.

7 COUNT VII -LEWDNESS WITH A CHILD UNDER THE AGE OF FOURTEEN

8 did, during or between 1995, and 1997, then and there wilfully, lewdly, unlawfully, and
9 feloniously commit a lewd or lascivious act with the body of [REDACTED], a child under the
10 age of fourteen years, by touching and/or fondling the vagina of the said [REDACTED] with
11 the intent of arousing, appealing to, or gratifying the lust, passions, or sexual desires of said
12 Defendant, or said child.

15 JUDGMENT OF CONVICTION (PLEA)

16 WHEREAS, on the 13th day of January, 1999, the Defendant ADAM LEVY, appeared
17 before the Court herein with his counsel and entered a plea of guilty, pursuant to North Carolina
18 v. Alford, 400 U.S. 25 (1970), to the crime(s) of **COUNT I and COUNT II - CHILD ABUSE**
19 **& NEGLECT (Gross Misdemeanor)**, committed during or between 1995 and 1997, in
20 violation of NRS 200.508 and

21 WHEREAS, thereafter on the 21st day of June, 1999, the Defendant being present in
22 court with his counsel ROBERT LUCHERINI, ESQ., and DOUGLAS HERNDON, Deputy
23 District Attorney, also being present; the above entitled Court did adjudge the Defendant guilty
24 thereof by reason of his Alford, plea of guilty and, in addition to the \$25.00 Administrative
25 Assessment Fee, sentenced Defendant to **Count I - ONE (1) YEAR** in the Clark County
26 Detention Center; **SUSPENDED** and placed on **PROBATION** for a **FIXED** period of **TWO (2)**
27 **YEARS. Count II - ONE (1) YEAR** in the Clark County Detention Center; **SUSPENDED** and
28 placed on **PROBATION** for a **FIXED** period of **THREE (3) YEARS, CONSECUTIVE** to Count
